**Wholesale Fish Dealer's License (Item 314) \$825.00**

Applicant hereby makes application for Wholesale Fish Dealer's License for the privilege of operating a place of business and buying for the purpose of selling, canning, preserving, processing or handling for shipment or sale, aquatic products, to retail fish dealers, hotels, restaurants, cafes, consumers or other wholesale fish dealers and is subject to all provisions and penalties provided by the laws of the State of Texas. Applicant certifies that he does not possess a Bait Shrimp Dealer's License and understands that a license for each place of business so operated is required and that the license shall at all times be publicly displayed in the place of business.

**Retail Fish Dealer's License (Item 302) \$92.40**

Applicant hereby makes application for a Retail Fish Dealer's License for the privilege of operating a place of business and buying for the purpose of sale or selling or offering for sale aquatic products to a consumer, other than aquatic products sold by restaurants, and is subject to all provisions and penalties provided by laws of the State of Texas. Consumer does not include a wholesale fish dealer, hotel, restaurant, cafe or other retail fish dealer. Applicant certifies that he understands that a license for each place of business so operated is required and that the license shall at all times be publicly displayed in the place of business.

**Retail Fish Dealer's Truck License (Item 316) \$171.60**

Applicant hereby makes application for a Retail Fish Dealer's Truck License for the privilege of engaging in the business of buying for the purpose of sale, or selling or offering for sale aquatic products to a consumer from a motor vehicle and is subject to all provisions and penalties provided by the laws of the State of Texas. Applicant understands the license must be displayed in the vehicle.

**Wholesale Fish Dealer's Truck License (Item 315) \$590.00**

Applicant hereby makes application for a Wholesale Fish Dealer's Truck License for the privilege of engaging in the business of buying for the purpose of selling aquatic products from a motor vehicle to retail fish dealers, hotels, restaurants, cafes, consumers or other wholesale fish dealers and is subject to all provisions and penalties provided for by the laws of the State of Texas. Applicant certifies that he does not possess a Bait Shrimp Dealer's License and understands this license must be displayed in the vehicle.

**Bait Dealer's (Item 515) – Place of Business – Building \$38.00**

Applicant hereby makes application for a Bait Dealer's License for the privilege of operating a place of business for the purpose of selling or offering for sale, minnows, fish, shrimp in non-coastal counties or other aquatic products for fish bait and is subject to all provisions and penalties provided by the laws of the State of Texas. Applicant certifies that he understands that a license for each place of business so operated is required and that the license shall at all times be publicly displayed in the building.

**Bait Dealer's (Item 516) – Place of Business – Motor Vehicle \$38.00**

Applicant hereby makes application for a Bait Dealer's License for the privilege of operating a place of business for the purpose of selling or offering for sale, from a motor vehicle, minnows, fish, shrimp in non-coastal counties or other aquatic products for fish bait and is subject to all provisions and penalties provided by the laws of the State of Texas. Applicant certifies that he understands that a license for each place of business so operated is required and that the license shall at all times be publicly displayed in the vehicle.

**Bait Shrimp Dealer's License (Item 335) \$215.00**

Applicant hereby makes application for a Bait Shrimp Dealer's License for the privilege of operating an established place of business, in a coastal county of the state, for compensation or profit for the purpose of handling shrimp caught for use as bait from the inside waters of this state, subject to all provisions and penalties provided by laws of the State of Texas. Applicant certifies that he does not possess a Wholesale Fish Dealer's License or Wholesale Fish Dealer's Truck License and understands that a license for each place of business is required and that the license shall at all times be publicly displayed in the place of business.

**Texas Finfish Import License (Item 380) \$95.00**

Applicant hereby makes application for a Texas Finfish Import License for the privilege of receiving directly from another state or foreign country, importing, transporting or selling commercially protected finfish and is subject to all provisions and penalties provided by the laws of the State of Texas. Applicant certifies that he understands that a license for each place of business so operated is required and that the license shall at all times be publicly displayed in the place of business.

**I understand that under Texas Penal Code §37.10, it is a felony to make a false statement on this form.** I further understand that dealers who purchase or receive aquatic products directly from any person other than a licensed dealer must file a monthly marine products report and issue and maintain cash sales tickets as prescribed by §66.019 Parks and Wildlife Code.
